Nearly one-third of people enrolled in Medicare (19 million) are enrolled in Medicare Advantage, and that number is expected to grow. New legislation and rules enacted in 2018 will give Medicare Advantage plans greater flexibility to offer a wide array of supplemental benefits (such as healthy meals and wheelchair ramps) to meet the needs of chronically ill beneficiaries. The Ins and Outs of Medicare Reimbursement for CBOs
